# **Introduction of FY 2019-20 Budget Process**

Presenter: Mike Franks, Budget & Special Projects Manager

Mr. Franks reviewed the FY19/20 budget calendar as well as the budget priorities. Council Member Kennedy asked Council to consider a policy regarding the upcoming budget and those moving forward to increase the operating budget only to the extent of revenue from taxes and revenue increases. He stated the Town has been on this trend for the last 4 years where the operating budget increased beyond the need to pay debt service at a faster rate than the source of revenues. The long term effect is the reserve balance is decreasing and it is important to look to the future to allow for opportunities and/or issues that may occur. Council Member Kennedy suggested possibly bringing this matter may need to be brought to the Law and Finance Committee for discussion.

After a brief discussion regarding the possibility of adopting a policy that might better address this matter, Mr. Dickerson responded the budget team is aware of the Council's concerns regarding fund balance and are implementing long term funding models and historical data as a means to obtain better estimates on items needed and replacement costs. The budget team is also working towards a better system to forecast expenditures and revenues.

### **UDO-18-02, Neighborhood Meetings**

Mr. Triezenberg presented the UDO text amendment submitted by the Planning Department to require applicant-led neighborhood meetings for any development application including a Conditional Use District Zoning, and Planned Development or Special Use Permit requests. The Planning Commission made several minor changes to the general approval procedures; specifically to the notification and meeting summary sections.

# Marshburn

• Expressed thanks to the MLK Committee for presenting the Dream in Action award to the Council.

Behringer

- Stated some trailers seem to appear to be dismantled near the railroad tracks and is concerned about safety.
- Reported the Wilson Fire Department obtained a grant from FEMA to upfit their facility to provide fire safety education and suggested this may be something the GVFD may want to look into.

### Singleton

- Stated Council hopes to select an individual to fill the Council vacancy within the next 4-6 weeks.
- Reported seeing highways in Wake County were being resurfaced/paved even in the winter.
- Shared highlights of Garner's past athletic achievements and sports programs over the years. Due to the quality of its athletes, at one time Garner was known as a "ball town". Mr. Singleton also commended the outstanding athletes in Garner's schools.

#### Kennedy

- Reported receiving inquiries regarding drainage at the vacant lot near the townhomes facing
  Aversboro Road beyond Old Town Drive. A detention pond is in the back and drainage from the
  northwest corner is causing problems as the house is sitting at a low elevation. Asked if it was
  possible for Public Works to install piping to move the water off the site to prevent water getting
  into buildings. Grading may also be needed.
- Near the townhomes facing Aversboro Road beyond Old Town Drive. A detention pond is in the
  back and drainage from the northwest corner is causing problems as the house is sitting at a low
  elevation. Asked if it was possible if Public Works can install piping to move the water off the site to
  prevent water getting into buildings. Grading may also be needed.
- Reporting receiving proposals to perform Phase 1 on the Yeargan property.
- Expressed concern regarding paving at the Rec Center during the winter.
- Asked if a plan and budget were adopted for the Garner Area Historic Society and Mr. Dickerson responded we were waiting on estimates from contractors and reported meeting with the Society on the 26<sup>th</sup> to review the site plan.
- Stated he received an inquiry about the property on Thompson Road at dead end; about 12 acres that backs up to the west side of White Deer Park. The owners want to sell and are not familiar with the zoning and restrictions. Mr. Triezenberg responded he was contacted by the property owner and their representative and advised there are a number of things that affect development potential additional points of access, zoning, Swift Creek Plan (which restricts development potential).
