# **Budget Amendment for Software Implementation**

# Tier 1 Conditional Rezoning # CZ-23-03, 309 Holman Drive

Tier 1 conditional district rezoning request submitted by Shalom Christian Community Church to rezone approximately 1.55 +/- acres from Residential 4 (R4) to Neighborhood Mixed Use (NMX C284) Conditional. The site is located along Holman Drive and may be further identified as Wake County PIN(s) 1710893586.

Dr. Lola Fuller, the applicant, thanked Council and staff for their hard work and assistance with the planning of this project.

Tier 2 Conditional Rezoning # CZ-PD-22-04, E. Garner Rd. Assemblage (The Park at Garner Station)

Presenter: Jeff Triezenberg, Planning Director

Tier 2 Conditional Rezoning request (CZ-PD-22-04) submitted by McAdams to rezone 96.73 +/- acres from Multifamily 1 (MF-1), Single Family Residential (R-40) and Single Family Residential (R-12) to Planned Unit Development (PUD C281) Conditional for a mixed-use development consisting of a maximum of 350 Single Family units, 600 Multifamily units, and 35,000 square feet of commercial space. The site is located along the north side of E Garner Road between Creech Road and White Oak Ridge Drive and may be further identified as Wake County PIN(s) 1711833114, 1711827887, 1711923791, 1711925082, 1711933576, 1711838749, 1711833775, and a portion of 1711945676.

At the meeting of March 19, 2024, the Town Council voted to continue this case until April 2, 2024, to allow additional time to study the proposed affordable housing conditions and to discuss architectural conditions.

Collier Marsh reviewed the proposed conditions and presented the architectural designs. Several members of Council expressed concern regarding the lack of time they had to review the information as well as the extension of Creech Road. Also of concern was the volume and density of this project, increased traffic, the impacts to North Garner as well as what was included in the development agreement.

Council Member Singleton requested the name of the project be changed.

Action: I move that the Town Council accept the Planning Commission's written statement regarding consistency of the zoning Amendment request with adopted land use plans detailed in Section VI of the staff report as our own, and I further move that the Town Council adopt Ordinance Number (2024) 5258 approving rezoning CZ-PD-22-04 as the request is reasonable in the public interest because it will most likely promote multiple family housing in select areas.

## **Park at Garner Station Development Agreement**

- Ms. Miller reported the beginning of the National Community Survey, a Town-wide survey to learn how residents feel about Town services and programs. All returned information will be combined into a report in the May timeframe.

- The Garner Town Employee Service Awards event is on Thursday, April 11<sup>th</sup> from 11:00 a.m. to 1:30 p.m. at the Garner Rec Center.

#### ATTORNEY REPORTS

- Ms. Jones provided a monthly report regarding the Walters Buffalo/White Oak/Bryan Road project.
   The right-of-way has not been acquired yet, so there may be a need for eminent domain action by the Town.
- There is a Special Council Meeting on April 3<sup>rd</sup> beginning at 2:00 p.m. in Council Chambers.

#### **COUNCIL REPORTS**

#### Behringer

- Asked when the damaged utility pole issue previously reported would be corrected. Ms. Miller responded that she would follow- up.
- Asked if any Council Members had attended the Lawndale Community Meeting regarding a rezoning. No Council Members attended and Planning staff were unaware of the results from that meeting.

## Gupton

Thanked Planning staff for ensuring Council Members were invited to attend community meetings.

## Dellinger

• Requested community meetings not be held on Council Meeting nights.

## Matthews

- Stated that he also appreciated the invitations to community meetings adding that it will be helpful for future planning endeavors.
- The open house at White Deer Park regarding the inclusive playground had a wonderful turnout and praised staff for the wonderful job they did.

# Singleton

Voiced concerns about the secondary entrance at The Avenue at White Oak. The road is dirt and is
not maintained. He requested that this area be improved and maintained along with the rest of the
project. Council Member voiced the same concerns. Mr. Triezenberg reported that this issue has
been brought to the attention of the developer, the HOA and NC DOT. If not corrected, a citation
will be issued for bare earth, as the UDO states that this is not permitted.
