Town Council Meeting Minutes

The Council met in regular session at 7:00 p.m. in the Garner Town Hall located at 900 7th Avenue.

Ralph Carson of Hay River Street expressed concern regarding road improvements related to the Amazon project. Specifically, delays in roadwork design, NC DOT encroachments on Jones Sausage Road, and signalization. Mr. Johnson advised the roadwork plans are under review at NC DOT. The road is going to be widened to support a 4-lane section with a median. Council advised Mr. Carson to meet with staff regarding this matter.

CUD-Z-19-01 & CUP-SP-19-01, Pine Ridge Apartments

Mayor Williams opened the public hearing and asked Mr. Bamford to present the staff report.

Conditional rezoning (CUD-Z-19-01) with associated site plan (CUP-SP-19-01) request submitted by Evergreen Construction Company to rezone 6.24 +/- acres from Community Retail (CR) to Multi-Family Residential (MF-2 C214) conditional use and to develop an apartment complex of 72 units (Pine Ridge Apartments). The site is located on the north and south side of Small Pine Drive and may be further identified as Wake County PIN# 1701-26-9118.

At this time, Mayor Williams closed the public hearing.

Action: Move the Town Council find that although the zoning request is inconsistent with the Garner Comprehensive Plan, detailed in Section IV of the staff report, it is reasonable and in the public interest because it will likely allow the development of an appropriate density of housing in the area in which it is located and allow household living and supporting day care uses that are attractive to younger families with children as well as older residents looking to maintain private but smaller outdoor spaces and therefore, move further that the Town Council adopt Ordinance (2019) 3969 approving rezoning request number CUD-Z-19-01, and in doing so, also amend the Town's Comprehensive Growth Plan from designating the subject property as High-Density Residential to Multi-Family Residential.

Grady Stevenson, 701 New Rand Road, expressed concern regarding relocation of the existing driveway. Staff advised this is probably a private matter between the parties and advised Mr. Stevenson to speak with the Town Engineer.
